Solid Waste Management District Announces Fiscal Year 2022 Grant Availability

Applications accepted from February 1, 2021 through April 1, 2021

The Northwest Missouri Regional Solid Waste Management District has grant funds available from the Missouri Department of Natural Resources Solid Waste Management Program to distribute to both public and private entities throughout Atchison, Gentry, Holt, Nodaway, and Worth Counties. The grant funds are intended to reduce the amount of waste entering the local waste stream and facilitate recycling. Some examples of projects include the purchase of woodchippers, aluminum and cardboard balers, forklifts, trailers, recycling bins, composting and other organic recycling projects. District Grant funds have also been used for outdoor classrooms, recycling education, rubberized track and recycling business expansion. 2020 TAP Call for Projects

Transportation Alternatives Program - Notice of 2020 Statewide Call for Rural Projects - Applications due January 29, 2021

The Missouri Department of Transportation (MoDOT) is seeking projects to be funded using Rural Statewide Transportation Alternatives Program (TAP) funds. This program call will award \$3.9 million of federal TAP funds. Local Public Agencies (LPAs) that reside within the Metropolitan Planning Organizations of OTO, MARC, and East-West Gateway are not eligible for this program call. Eligible projects include:

- Construction of on-road and off-road trail facilities for pedestrians, bicyclists, and other non-motorized
 forms of transportation, including sidewalks, bicycle infrastructure, pedestrian and bicycle signals, traffic
 calming techniques, lighting, and other safety-related infrastructure, and transportation projects to
 achieve compliance with the Americans with Disabilities Act of 1990;
- Construction of infrastructure-related projects and systems that will provide safe routes for non-drivers, including children, older adults, and individuals with disabilities to access daily needs;
- Conversion and use of abandoned railroad corridors for trails for pedestrians, bicyclists, or other non-motorized transportation users; and
- Construction of infrastructure-related projects to improve the ability of students to walk and bicycle to school, including sidewalk improvements, traffic calming and speed reduction improvements, pedestrian and bicycle crossing improvements, on-street bicycle facilities, off-street bicycle and pedestrian facilities, secure bicycle parking facilities, and traffic diversion improvements in the vicinity of schools.

Awarded projects will be funded with a maximum 80 percent federal funds and require a minimum 20 percent local match. A project must seek a minimum of \$100,000 of federal reimbursement. The maximum federal reimbursement is \$400,000. Applications are due to the respective District Office by **Friday, January 29, 2021**. Awards are anticipated to be announced in late March 2021. COVID-19 Wastewater Analysis Opportunity

AquaVitas, LLC, a wastewater analysis company, is looking for wastewater systems in Missouri that would be interested in joining a study for COVID-19 wastewater analysis. The U.S. Department of Health and Human Services (HHS) in partnership with the Centers for Disease Control and Prevention are conducting this study to provide information for wastewater-based epidemiology efforts. Please refer to this website for more information about the project and sampling requirements. This study requires that participants ship one 24-hour influent sample to their laboratory for analysis. AquaVitas provides and funds all supplies. If your community and treatment plant are interested in participating in this study, please reach out to AquaVitas as soon as possible and mention the HHS Project. They are currently recruiting participants for their Phase 2, in which "additional treatment plants will be enrolled to cover at least 30 percent of the US population and continue testing for an additional nine weeks." They expect to reach their targeted number of samples by early February. Final decision for participation will be made by HHS.
