# From the RCOG

Hi all, we are excited to bring you our 2023 Annual Report and Public Officials Directory. 2023 has been a whirlwind... a whirlwind of new projects, new grants, and more. Kim secured a grant through the FCC to promote the Affordable Connectivity Program and we hired Joy Huddleston to be the Coordinator for that program; staff worked together to complete three RAISE Planning Grants, one of which was funded; Intern Sarah lost her "intern" status upon graduation from Northwest and is now Assistant Regional Planner working primarily on transportation-related projects, and Steve kept our technology working during all the madness while also writing Hazard Mitigation Plans. We've had two different Solid Waste Planners this year and hired one new intern. This year, our board made the decision to no longer offer Workforce Development services so we did not bid on the new contracts to continue services which means we no longer have a job center in our building. St. Joseph Youth Alliance got the contract for services in our region and they have opened up a job center location on East Summit in Maryville. We are please that the people in our region will still receive services without having to travel to St. Joseph, Chillicothe or Trenton. Our contract ended June 30, 2023, and that was also Rita's last day with us as she chose to seek employment elsewhere.

We also transitioned to a hybrid work schedule and a 4-day work week in 2023. This has taken some getting used to but everyone has adapted well. Thanks to technology we haven't missed a beat with our new schedule. This year, we were awarded a USDA grant to help fund renovations for the first floor of the Regional Council office. We hope the renovations will begin shortly after the first of the new year and we are so excited to have an area that suits our growing staff's needs.

# Transportation Planning

The Regional Council continues to serve as the leading voice for regional transportation planning in northwest Missouri, and remains a steadfast supporter and facilitator of communication between MoDOT and the cities and counties of northwest Missouri. In support of regional transportation planning, the Regional Council develops and executes an annual transportation work plan designed to allow local, grassroots input to statewide transportation planning.

To assist with this planning, the Transportation Advisory Committee, or TAC, serves as a standing committee of the Northwest Missouri Regional Council's Board of Directors. The TAC is comprised of elected officials, city and county representatives, and local citizens from the region's five counties, and serves as the heart of local planning efforts. The Committee meets on a quarterly basis, and assists in the identification of regional needs for transportation infrastructure, public education, and safety in MoDOT's Northwest District.

For the past 18 years, the Regional Council has served as a member of the Northwest Missouri Coalition for Roadway Safety (Blueprint), which strives to decrease the number of deaths and injuries on our roadways. The group meets bi-monthly. Regional Council staff serves on the Blueprint Grant Scoring Committee and has a spot on the Impaired Driving Subcommittee.

The Regional Council shares a speed trailer with MoKan and Green Hills RPCs. The speed trailer can be deployed to gather data and assist with traffic calming efforts throughout the region. Additionally, the Regional Council has an Armadillo Traffic Counter that is a great tool for gathering data as needed on different streets and roads. If your jurisdiction would like to use either of these devices, please call or email Amy.

This year has been a big year for Transportation Planning grants for the Regional Council. Like last year, the Regional Council applied for a Community Active Transportation Plan through the Missouri Department of Health and Senior Services and was awarded the grant mid-year. The Regional Council chose to write a Community Active Transportation Plan for the City of Rock Port and began the project July 1<sup>st</sup>. The Regional Council staff worked in conjunction with the City of Rock Port to create a community-driven, forward-thinking plan that will

benefit Rock Port for years to come. This plan was approved by the Rock Port City Council on September 20, 2023, and will be used to help guide sidewalk improvements, score more higher on grant applications due to the presence of a Community Active Transportation Plan, and inspire other active transportation projects in the future.



We are proud to introduce a new Roadway Safety Program! In 2023, the transportation staff applied for a Roadway Safety grant from MoDOT to rejuvenate a roadway safety education program for high school and college age individuals. We hired Alex Dandy, a student at NWMSU to facilitate the program. Reaching the 5-county area of Atchison, Gentry, Holt, Nodaway, and Worth—presentations on topics in roadway safety, events involving impaired driving information, and more are on the agenda for not only this year but for many to come.

Alex's first presentation was on November 7 at Jefferson C-123. Getting out to meet the students was amazing, as well as all the great information shared. The students got to participate in a fun little activity using the Drunk Buster Goggles which really got them involved.



Outside of the in-person events, we are also working on our social media presence. The growing technological presence we see in society shows the importance of getting in touch with the community online. Having accounts on Instagram, Facebook, and TikTok is helping our outreach of Roadway Safety information and will help inform followers of upcoming events. # Transportation Planning

**Safe Streets and Roads for All (SS4A).** What is Safe Streets For All (SS4A)? SS4A is a federal grant program that will provide \$5-6 billion in grants over the next 4 years. It is funding that is intended to directly support regional, local, and Tribal initiatives through grants to prevent roadway deaths and serious injuries. The first round of SS4A opened and closed last year, with most projects funded and with money left over. The second round of funding opened in April and the Regional Council submitted proposal for a Regional Safety Action Plan for Atchison, Gentry, Holt, Nodaway, and Worth counties, requesting \$393,971. We were able to secure match commitments from all five of our County Commissions which helped our application stand out as a community-driven project. Awards were recently announced, and we received notice that our grant application was selected! We are excited to move forward with this grant opportunity to help make the region’s roads safer and eventually reduce/eliminate roadway crashes and fatalities.

We want to develop a comprehensive safety action plan that is community-driven, fact-driven, and that will lead to the decrease of roadway fatalities and serious injuries in our five counties. In the development of this safety action plan, we seek to excite the community and begin changing the driving culture in our region.

Roadway safety should always be a top priority, but in rural America it often falls to the backburner due to a myriad of reasons, like lack of funding or driving culture. The Regional Council is committed to bringing roadway safety to the



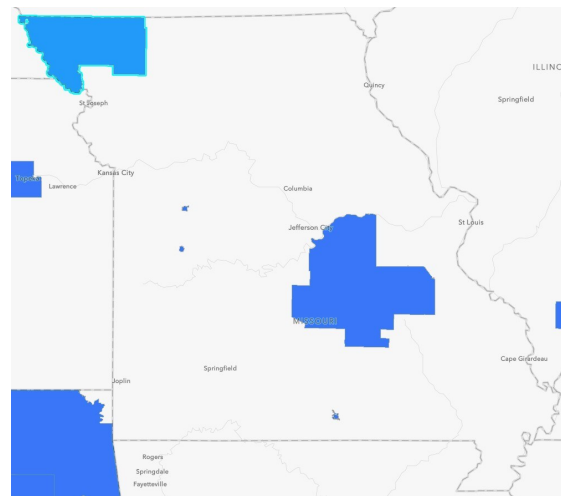
forefront and has been cultivating change through many avenues. In the past year, the Regional Council staff has updated a handful of transportation related plans to prioritize existing safety issues, as well as developing two Community Active Transportation plans to enhance accessibility and address safety issues with alternative transportation methods.

We are excited about the opportunity this SS4A grant provides to develop a comprehensive safety action plan for our region. We feel like this is the next step to help achieve our goal to decrease, and eventually eliminate, roadway fatalities and serious injuries in our 5-county region

Our plan is to develop a comprehensive safety action plan that caters to the wants and needs of the region. The development process is anticipated to span 12-18 months to ensure the project is comprehensive, in-depth, and an excellent fit for the community. The Regional Council staff plans to be active in the region to drive public engagement for the project. At least eight public engagement meetings will be scheduled to gather information, ideas, and concerns from the public. These meetings will rotate locations, so each county is visited at least once. Surveys will also be available to the public to ensure that even those who can’t attend in-person meetings can have their voices heard.



# Solid Waste District

**About the Solid Waste District Region A.** The Northwest Missouri Regional Solid Waste Management District (SWMD), Region A, serves the same five-county region as the Regional Council, providing local communities and governments easy access to waste education technical services. RCOG staff provide administration, education, and



implementation of the Northwest Missouri Regional Solid Waste Management Plan. It is one of 20 Solid Waste Management Districts operating with oversight provided by the Missouri Department of Natural Resources. The SWMD is directed by local leaders

appointed to participate on the Full Council, Executive Board and Advisory Committee. Its goal is to educate and support recycling efforts in our region, and to encourage “reduce, re-use & recycle”.

**FY '23 Grant Call.** Reimbursement grant funds are available each year through a competitive application process. For each grant call, the Advisory Committee reviews the grant applications and makes recommendations to the Executive Board. The Executive Board then evaluates, and ranks grant applications to award grant funds for community projects. Eligible projects must address reducing the amount of waste entering local waste stream and/or facilitating recycling. Funds can be used for various projects, including but not limited to waste diversion, creating opportunities for recycling, creating new market research and development, collection and processing of compost, and providing education on recycling. District funds have also been used for



and processing of compost, and providing education on recycling. District funds have also been used for

outdoor classrooms, rubberized track and playground surfaces and recycling business expansion. One grant call was held for FY'23. Ten grant applications were received. Due to available funding, only eight of the ten were awarded for a total of \$74,459.79, plus \$47,500 for Plan Implementation and District Operations.

**FY '23 Solid Waste District Highlights.** The Northwest Missouri Regional SWMD continues to support the growing recycling infrastructure that provides increased collection bin availability at the community level and a network of collection sites to encourage proper disposal



Collection site. Five HHW collections were held in FY '23, serving 145 residents and diverting over three ton of household hazardous waste from entering the local waste stream.

Plan Implementation (PI) funds were utilized to host community education and collection events focusing on white goods and e-waste, educational events around Earth Day to highlight the importance of reuse, collection boxes for crayon recycling at local schools in the District, and to continue supporting HHW outreach. The white goods and e-waste collections diverted over 5 tons of waste over 5 collections. Recycling capability and infrastructure has been expanded through various grants from FY '23.



# SWMD Grant Funded Projects

## A2023-001 - District Operations - \$40,000

District A conducted all daily operations and fiscal operations what included the administering District projects, completed quarterly reports, and submitted the annual report.

## A2023-002 - Plan Implementation - \$7,500

E-waste/White Goods Collection events were held in Albany, Grant City, Ravenwood, Rock Port, Fairfax, Tarkio, Burlington Jct, Stanberry, King City, Jefferson School, Maryville, Hopkins, Barnard, Oregon, Mond City and Graham MO. Dave Chestnut with Nodaway County Recycling was contracted to collect the waste at each event. Over 5 tons of materials were collected. Community education events were held in observation of Earth Day, Saturday, April 22, 2023.

## A2023-003 - Stanberry Bulldog Recycle 2.0 - \$15,848.79

The Stanberry School expanded their recycling program. The school continues to collect plastics and recycle paper/cardboard and added the collection of aluminum cans and tin cans. The school purchased the following: metal materials and made recycling bins to collect the aluminum and tin cans, a utility trailer to transport the recyclables, 2-picnic tables, made from recycled materials, a can crusher, weights made from recycling materials for the weight room and gloves/trash can liners for the bins. Students are very involved in the recycling project. The Stanberry community has a drop-off location for recycling.



## A2023-004 - Albany R-3 Earth Science Class - \$2,586

The Earth Science class project expanded recycling to include plastics, aluminum, and tin cans from the school kitchen. Students in Earth Science are responsible for collecting, preparing the waste, weighing, and placing it out for pickup.



## A2023-005 - NWMSU Composting - \$19,500

Northwest Missouri State University purchased a new industrial shredder to support food waste composting efforts on campus. The equipment substantially increases the efficiency and effectiveness of current food composting efforts, centered on the primary food service facility on campus.

## A2023-006 - WCCC Recycling - \$7,525

Worth County Convalescent Center expanded recycling at their facility to add large #10 (20+ oz) tin cans that are used during food preparation. Following state regulations, WCCC needed a way to store food cans compactly outside the building. An industrial can crusher was purchased. In addition, an outside employee break area with designated recycling bins were purchased and are being utilized. Other materials purchased were one handicapped 8' picnic table and two 6' park bench made from recycled materials. The facility staff prepare the materials for recycling pickup by Rolling Hills.

## A2023-007 - HHW Vendor Pick-up - \$19,000

In 2016, the Nodaway County Commission established a permanent Household Hazardous Waste (HHW) Collection Site at the Nodaway County Maintenance Barn, 1516 East Halsey St., Maryville, MO 64468. This site is available to the 39 communities served in our 5-county area and was open for five collections throughout FY23. The grant covered the cost of HAZWOPER certified personnel to intake materials on collection days, the proper containers, and pick-up of the HHW materials, and the required HAZWOPER continuing education. Clean Harbors collected the HHW materials. The Regional Council provided public education and outreach about HHW materials.

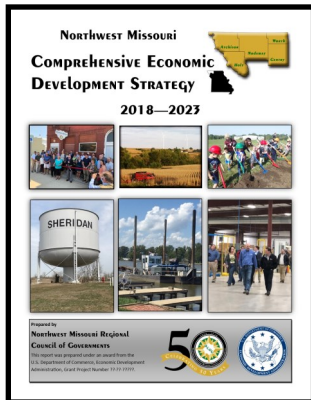
## A2023-008 - Nodaway Co Recycling/Sheridan - \$10,000

A 30' trailer was purchased for Nodaway County Recycling to collect metals in the town of Sheridan. Educational materials were provided to the Sheridan area residents, and the collections were staffed by RCOG personnel.



# Economic Development

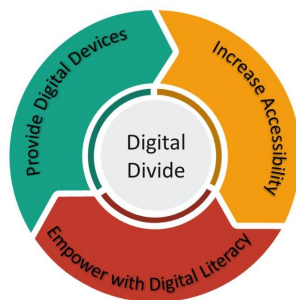
The Department of Commerce-Economic Development Administration (EDA) federally recognizes the Northwest Missouri Regional Council of Government's five-county region as an Economic Development District. As part of that designation, EDA supports the Regional Council with an annual partnership planning investment, which is used to facilitate the development, implementation, and revision of the Comprehensive Economic Development Strategy (CEDS). The 2018-2023 EDS was adopted on October 25, 2018. Since the plan's adoption, the Regional Council and its partners have worked on several projects featured throughout this report related to the document's goals to help northwest Missouri grow and prosper.



## Broadband Access, Equity, and Digital Literacy

On July 1, 2023, the Northwest Missouri Regional Council released the Northwest Broadband Plan created with the University of Missouri Extension Digitally connected framework. A team comprised of local economic developers, and extension staff worked to create the plan. This plan has been used by Internet Service Providers, the Regional Council, and the University of Missouri Extension to secure grant funding and host events.

In August, the Regional Council teamed up with the University of Missouri System Broadband Initiative and MU Extension to develop an economically sustainable, public-private partnership (P3) business model competition to design affordable access to high-speed internet (broadband) for residents and businesses in northwest Missouri.



Multidisciplinary teams of students from UM System universities competed to develop P3 business models using surveys, research, data, and discussions to develop workable and affordable plans for infrastructure expansion and service adoption in northwest Missouri. Each P3 business plan addressed strategies for increasing the adoption of internet-based technologies and a plan to finance and construct the community's internet network. On August 20 the teams presented their proposals to a panel of judges at a public event in Maryville Missouri. The teams' plans were integrated into the regional planning efforts.

In addition, the Regional Council collaborated with the University of Missouri Broadband Initiative Team to pilot the Missouri Digital Ambassadors program. Volunteers interested in becoming Digital Ambassadors receive 14 hours of in-person training in August 2023. Working through community partners such as libraries, schools, senior centers, and civic groups, Digital Ambassadors will share their knowledge – in group settings and one-on-one interactions – on a variety of topics, including telehealth, job searching online, videoconferencing, cybersecurity, social media, cloud resources and document applications such as Google Docs and Office 365.

Missouri Digital Ambassadors is based on programs such as Missouri Master Gardeners, in which gardening enthusiasts receive extensive training and share what they know with other gardeners in a variety of settings. This project was funded in part through a \$25,000 Digital Demonstration Projects Grant Program offered by the Office of Broadband Development.

Over the past year, the Office of Broadband Development provided public engagement service as the division crafted its state plans for the Broadband Equity and Deployment Program and Digital Equity Act program. The Regional Council hosted two listening sessions in Maryville and ensured that stakeholders were able to participate in monthly virtual meetings related to reliable and affordable access, partnerships with local governments, workforce development, digital literacy and equity programs, the Missouri Internet Survey, and the Missouri Digital Asset Map.

# Economic Development

## Affordable Connectivity Program

The Federal Communications Commission (FCC) launched the Affordable Connectivity Program (ACP) in an effort to close the digital divide by providing Americans in need with the opportunity to receive discounted rates on their broadband internet bill. Eligible households that take part in the program can receive a monthly credit of up to \$30 towards their internet bill (\$75 on Tribal lands). The Regional Council was rewarded with a grant to assist in outreach efforts for ACP, to spread awareness about the program in the five counties and increase enrollment rates.

This year was the start of the Regional Council's two-year ACP plan. During the summer and early fall, efforts were focused on outreach. Kim hit the ground running by attending Back to School Fairs for all five counties to inform families about ACP and take down contact information for future enrollment events. From there, Kim and Joy conducted outreach at various events, including Northwest Missouri State University's Part-Time Job Fair, Maryville's

Downtown Market, and Northwest's Exploring Majors and Minors freshman event. Talks about ACP were also given at senior centers and assisted living homes. Aside from in-person outreach, the Regional Council took out ads in seven different newspapers, as well as radio ads on KNIM, KVVL, and Bearcat/Spoofhound Radio.

In October, while outreach is still being conducted, focus started shifting towards enrollment. Kim and Joy hosted their first enrollment event at Autumn House in Maryville and have since been taking appointments in the Regional Council office. We have officially partnered with Knacktive, a program for advertising and marketing students from Northwest, to create an advertising campaign targeted towards college students starting next year. We have also begun working with Second Harvest Food Bank, joining them at food dispensing events to hand out informational materials about ACP. We

hope to continue to collaborate on similar events in the future and to continue to increase awareness about ACP in the five counties. If you have any questions or would like help enrolling, please contact Joy.



# Other Projects

**Hazard Mitigation Planning.** Hazard mitigation is the means by which communities, businesses and citizens can reduce the impacts of a disaster by taking action before a hazard event occurs. The first action necessary to reduce the effects of a disaster is the preparation and implementation of a mitigation strategy presented through a hazard mitigation plan. This effort is completed by coordinating meetings among local elected officials, school district officials, local citizens, and representatives from businesses and service agencies to review goals, objectives and achievable actions that will address their community's vulnerabilities in the occurrence of a natural disaster. In 2023, FEMA approved the 5-year updates to the AMEC plan and the Nodaway County plan.



The Regional Council assisted several jurisdictions with Hazard Mitigation Grant applications. Mound City and Worth County were awarded grants for generators and Big Lake and Craig were awarded grants for outdoor warning sirens. We are now helping administer the completion of the projects to ensure the state and federal guidelines are followed.

**Great Northwest Wholesale Water Commission.** Great Northwest Wholesale Water Commission is well underway with construction of the regional water system. The finished project will provide drinking water to the cities of Cameron and Maysville to ensure a more reliable access to affordable, clean drinking water during drought related times. The Northwest Regional Council continues to provide support to the Great Northwest Wholesale Water Commission, serving as the administrative agent for the Great Northwest Wholesale Water Commission.



The project includes the installation of 36-Miles of Pipeline and Two Master Meter Vaults, the erection of a 450,000-gallon Ground Water Storage Tank, Package Pump Station at the east edge of St. Joseph, Missouri and, the erection of a 300,000-gallon Elevated Water Storage Tank east of Stewartsville along Highway 136. Construction contractors who were awarded the bids included: BRB Contractors, Inc from Topeka, KS; Irvinbilt Constructors, from Chillicothe, MO and Caldwell Tanks from Louisville, KY. Missouri American Water in St. Joseph will provide the water source. The project is being funded by USDA-Rural Development, through both grant and loans. Completion is expected in 2024.

**604b Water Quality Management Grant.** The Regional Council was awarded a Missouri Department of Natural Resources, Water Quality Management Grant, also known as a 604(b), on behalf of the Village of Big Lake, City of Craig and Big Lake State Park. Snyder & Associates, St. Joseph, MO was selected as the engineering firm to complete a Preliminary Engineering Report. The project was completed 9/30/2023.

The Regional Council applied for another grant in February 2023 for the communities of Fairfax, Rock Port, Tarkio and was awarded 7/1/2023. The project's overall goal is to determine the feasibility of developing a regional wastewater system in the designated project area. 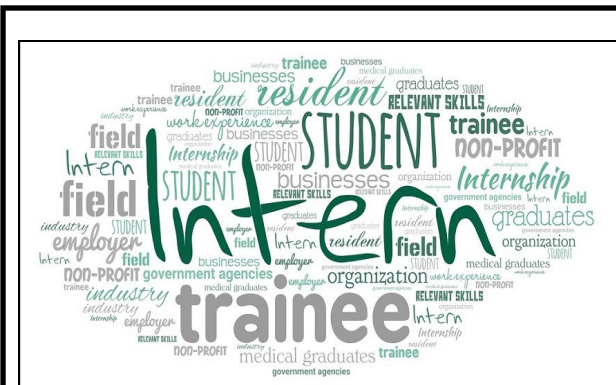
